

An Introduction to Low Vision Rehabilitation: First Response Interventions for Older Adults

Suggested Audience:	This seminar is designed for therapists (occupational, speech, physical therapists) who work with older adults.
Course Descriptions:	<p>In four courses, the student will learn how to evaluate and provide “first response” rehabilitation interventions for visual impairment. “First response” interventions are interventions that maximize vision, or compensate for vision loss using resources available in acute, sub-acute or home-care rehabilitation services. These courses provide practical and immediately applicable information as well as a solid starting point for those who wish to specialize in low vision rehabilitation. The presentation will involve an interactive power point presentation, richly illustrated with graphic and video demonstration where you view the world through the eyes of people with different types of vision impairment. Participants will apply techniques using videos of real patients. In our interviews with two people with vision impairment you will discover how well people can function with the right education and rehabilitation. Courses may be taken separately. Grouped courses and the seminar version.

Courses have been grouped and discounted to encourage students to complete all four as was originally intended. The seminar version is offered to provide the opportunity to add live interaction to the course. In the seminar version, students meet to discuss cases presented in the Courses 2 and 3 workshops. The examination includes questions about these specific cases. However, examinations must be taken individually for credit. We also recommend that seminar leaders who have some training in low vision rehabilitation lead these seminars, although this is not necessary.

About the presenter:

Steve Whittaker is a practicing occupational therapist and certified low vision therapist. Steve has been involved in low vision rehabilitation for over 30 years as a researcher, educator and practitioner. He currently serves as member of the low vision expert committee of the Academy for Certification of Vision Rehabilitation and Education Professionals (www.ACVREP.com). He has numerous scientific publications, has received grants from The National Eye Institute, NASA and lectures internationally. With a doctorate in experimental psychology and post doctoral training in visual neurophysiology, Dr Whittaker began researching eye movements anomalies associated with macular degeneration at the Pennsylvania College of Optometry (now Salus University) where he served as a researcher and educator for 20 years. He currently provides outpatient services as an occupational therapist at MossRehab in the Philadelphia Area and co-authored *Low Vision Rehabilitation: A Practical Guide for Occupational Therapist* (Slack, 2007).
